## Types of Federal Aid

- Federal Pell Grant = FREE money
- Federal Stafford Loans
  - Subsidized Loans = Government pays the interest while you are enrolled at least halftime and during a 6 month grace period.
  - Unsubsidized Loans = Government does Not pay the interest. You do have the option to pay the interest while you are in school.
  - Parent Plus Loans = Loan that a dependent student's parents can take out. It is based on credit.

- In order to repeat you will need to have a "0" balance
- There is no financial aid for repeating a single course
- There is possible financial aid for repeating entire term. Contact financial aid to determine eligibility.
- Students retaking one course must pay in full for that class one week prior to the start of class
- Payment plan must be in place for a student repeating an entire term and does not have enough financial aid to cover the balance



## Early Withdrawals by Term

- Students withdrawing from a FT program after the 1<sup>st</sup> day of class are eligible for partial refunds
- Tuition refunds are calculated using the last day of attendance in conjunction with the school's Tuition Refund Policy
- The following are results of early withdrawal from a FT program:
  - You may owe the school a balance
  - Your FA may be returned
  - You will not be permitted to come back until you have a "0" balance
