Program Environment Indoor/outdoor Dust/dirt/fume/noise etc. Layout of room – theory/lab	<ul style="list-style-type: none">The indoor classroom setting will range from 25 students to perhaps as many as 60 in one classroom.Students must be able to self-advocate and seek out assistance if they want it or need it.Our classes are held in a public building where other industry professionals come to train, good behavior and self-control is extremely important.Outside training will happen regardless of weather/temperatures but is limited during Jan., Feb., due to cold.Student awareness of the weather and the ability to dress accordingly is important.Teamwork and communication are keys to success in this program.	
Action/Need:		

Typical level of support	<p>IU13 support teachers and paraeducators check in on classrooms for brief periods of time throughout the day, often once or twice a day. IU13 learning support teachers may support 4-6 programs. IU13 emotional support teachers support their students in all programs throughout the building. Paraeducators may support 7-10 programs. The learning center is available at designated times for testing accommodations, study groups, work completion support, and instructional groups on IEP goal areas. Time spent in the learning center limits time spent in labs, so students must make the most of their brief time in the learning center. Services are at an itinerant level. IU13 teachers and paraeducators are unable to be in every program all day due to the itinerant nature. It is not a co-taught structure.</p>

Reading / ELA Levels: <i>Examples:</i>	<ul style="list-style-type: none"> Students must be able to read and comprehend at or above a 9th grade reading level. Reading with comprehension of what is being read is vital to grasping the concepts and foundational knowledge of all subjects presented in this program.

Writing Levels: <i>Examples</i>	<ul style="list-style-type: none"> Students will need to be able to document various events that happen each day in a journal type entry. Patient care reports and short scene/patient assessments will be part of the NREMT Course. Traffic citations and other law specific reports are also part of the law enforcement programs. Writing legibly, with complete and proper sentence structure is important to all levels of this program.

Math Levels: <i>Examples</i>	<ul style="list-style-type: none"> All portions of Protective Services have various basic math knowledge incorporated into them.

	<ul style="list-style-type: none"> For example, Water availability vs flow amounts, Speed vs posted limits, Speed vs. vehicle accidents, medication administration vs prescription. Just to name a few. 	
Action/Need:		
Science Levels: <i>For Medical programs and PSA</i>	<ul style="list-style-type: none"> Science, Physics and chemistry are all part of Protective Services. For example, when we study the human body and the diseases or illness of the body it is key to understand how pathogens affect the systems of the body. With the understanding of signs and symptoms of illness we can better understand what is happening to a patient and how to treat their conditions as we discover them. In Hazardous Materials and Fire, we need to understand air currents, water currents, and where certain chemicals, vapor clouds or types of smoke will flow to and its possible impact. Understanding this will allow us to help keep people and property safe.

Theory time	<ul style="list-style-type: none"> During Fire courses the Theory/Skills time is about 50/50 During National Registry EMT the Theory/Skill time is 60/40 Law Enforcement is about a 60/40 split as well 	
Action/Need:		
Homework <i>Amount per night</i>	<ul style="list-style-type: none"> Students have approximately 1-2 hours depending on mode of transportation and the activities of the day, for independent classroom study time. During NREMT, if a student wants to do well and gain certification, they will further their foundational knowledge outside the classroom setting. Typically, students spend 3-5 hours a week on homework during this time.

Lab Time <i>Guided vs Independent Work</i>	<ul style="list-style-type: none"> • All skills and Lab time are under the watchful eyes of instructors. • Students are shown the skill, given the steps for safety and proficiency, after which they are given time to review and practice with a partner and or instructors present. • Students can be found working as a team or group for certain skills. • Still other skills the student will be tested and graded individually.

Action/Need:

Tests <i>NOCTI testing – Y/N</i> <i>Frequency of tests/quizzes</i>	<ul style="list-style-type: none"> • NOCTI Testing is a metric by which all students attending this program will gain a Certificate of Completion. • Students will take a computerized “written” Pretest at the beginning of the school year and then at the end of third quarter they will participate in a Final Computerized “written” test, as well as skills demonstration in the following areas. Donning of Turn Out Gear and Self-Contained Breathing Apparatus, Water Supply, Traffic Stop and Citation writing, A written Hazardous Materials identification exercise, Bag-Valve Mask Ventilation of an Apneic Adult patient, and Cardiopulmonary Resuscitation of an Adult patient. Students will gain a Basic, Competent or Advanced score based on their performance. • All material is covered numerous times throughout the courses in this program.

Behavioral Expectations <i>Executive Function</i> <i>Organizational skills</i>	<ul style="list-style-type: none"> • The Protective Services Academy is meant to be more regimented than perhaps a class at your local high school. • PSA introduces students to the community expected higher standard of personal behavior, dress and teamwork of public service. Our program is held in a public building.

	<ul style="list-style-type: none"> Because of this student behavior, participation and attitude is witnessed by professionals in the very industries they may want to later be employed in. Students are held to a higher standard just like if they were employed by a law enforcement agency, EMS Organization or Fire Department. <p>EXCLUSION FROM THE PROTECTIVE SERVICES ACADEMY</p> <p>Our Protective Services Program is housed at the Lancaster County Public Training and Safety Center. This facility is operated by Lancaster County and is open to the public. The county reserves the right to suspend or permanently remove individuals from the building for conduct or safety reasons. This includes CTC students who attend the Protective Services Program. These decisions are made based on the county's own policies, which are separate from the policies and procedures outlined in this handbook. Any PSA student who is permanently barred from the Lancaster County Public Training and Safety Center for conduct on county property will be removed from the Lancaster County CTC and the student will be supported in transitioning to an alternative placement determined by the sending school.</p>
